## 8. Borough and County Council Reports

Cllr. Margaret Allingham reported that at the last HEWEB Local Area Committee meeting it was resolved to permit the Construction of 98no. Dwellings with access from Barbe Baker Avenue and Barnsland. In addition, the committee agreed to permit the Planning Application at 1 Pudbrooke Gardens from change of use from domestic dwelling to residential care home.

Cllr. Jerry Hall reported that he was pleased to see that in the Chancellor of the Exchequer's budget, provision has been made for the Botley Bypass and Chickenhall Lane albeit a bid will need to be made and may not be guaranteed. He referred to the work being undertaken to widen the drains at Hobb Lane in light of recent flooding. He stated he is a member of the Fleming Park committee and gave an update to developments in this respect.

Cllr. Derek Pretty advised that the planning application for the land north and east of Boorley Green is being discussed at the HEWEB LAC meeting on 21 March 2016 at the Botley Community Centre. He advised that Hampshire County Council has increased its Council Tax requirement by 3.99%, Eastleigh Borough Council is at 0% and Hedge End Town Council at 1%. He sought support for the planning inspectorate query on the planned development at the Land off Bubb Lane in proximity to the crematorium. The hearing is taking place on 12 April 2016 at the Ageas Bowl starting at 10.00am.

In the absence of Cllr. Bruce Tennent, the Town Clerk read his prepared report, which centred on education.

Cllr. Helen Corben formally thanked all members for the flowers recently sent by the Town Council and the cards she received, which were much appreciated.
