H123 Correspondence:

i) Caroline Mekky, Community Transport Projects Officer, HCC re Eastleigh Passenger Transport Forum provides a copy of notes from the Forum held on 25th November, 2009 and a copy of the new Fact Sheet About Bus Services. - iii) Notification of Tree Preservation Order No. 672, 16 Foord Road in respect of one Oak on the frontage of said address. Noted.
- iv) An Email from Stephen Bradbury, Assistant Highway Engineer, Hampshire Highways confirms that he has inspected the footway in Wildern Lane, from Budgens to Goodalls Lane. There are some alteration and resurfacing outside number 41 Wildern Lane that will be completed in February 2010. Until April 2010 nothing can be done to improve the overall footway but a bid for special maintenance funding to

resurface the complete section will be submitted at the end of May 2010 for approval for works in 2011 - 2012. Noted.

- v) An Email from Jon Riddell, HEWEB Local Area Co-ordinator informs HEWEB parishes that Ken Thornber, Leader of HCC, will be supplying 4,000 extra salt bins, which would indicate up to 100 potentially for the HEWEB area. The Town Council have been asked to propose key problem areas for salt/grit bins to be located. The Town Clerk has raised the following list, considering school routes, medical services, steep inclines and hopefully covering each large residential area with at least one if not two bin sites:

 - 17. Upper Northam Road (end of Turnpike Way)
 - 18. Shamblehurst Lane South (St. Luke's Church and Doctors Surgery)
 - 19. Centre of Hedge End Village
 - 20. Hedge End Police Station, St. Johns Road (to cover community facilities, car parks and local residential streets)
 - 21. Sunday's Hill, Bursledon Road
 - 22. Locke Road (within Botleigh Lakeside Estate)
 - 23. Netley Firs Road (to cover St. Catherines View, Upper Northam Close and Upper Northam Road)

Recommendation: Members agreed the following alterations to the aforementioned proposed list:

- 25. Charles Watts Way Supermarket Footbridge

H124 Planning Applications:

F/09/66414, 18 Pretoria Road. Creation of rear vehicular access. A letter of objection from Mrs. W. L. Hammerton, 25a St. Johns Road outlining the following:

- 1. It would create more traffic problems with extra cars coming and going as children play in this area. The applicant said that he would like to get cars to the rear of his house to enable him to do repairs.
- 2. Would also create extra parking difficulties as this space is used for parking by residents because the Nursery in St. Johns Road causes parking problems
- 3. Would not be in keeping with the surrounding trees and bushes as there would be a pair of gates on show
- 4. Also after 7 years of usage would be able to use access for a building e.g. bungalow etc.

In April, 2009 the applicant actually contacted each resident personally who own the private road asking permission for access to the rear of his property and all refused. This is a private road for which the residents pay upkeep.

Recommendation: No objection with reservations as to suitability within a private road.
