Councillors raised the following Highway Matters with the Town Clerk to seek resolution:

- Cllr Garton noted that the sign on the roundabout at Sainsburys is still leaning.
- Cllr Garton noted the sign on Charles Watts Way near Turnpike Way which is also leaning over.
- Cllr Garton raised the poor road surface on Botley Road between Peter Cooper/ Lexus to Bradbeers roundabout.
- Cllr Pretty raised the pothole on Shamblehurst Way leaving the roundabout.
- Cllr Shepherd raised that there is a pothole on the exit slip from the Next store.
- Cllr Shepherd noted that the barrier outside B&Q still needs fixing.
- Cllr Carnell reported that the keep left bollard in the Town Centre is still laying flat.
- Cllr Carnell reported the west bound on slip from Jct 8 and the east bound slip on Jct 7 used to be a through lane and is now a filter. Could appropriate signage or road markings be applied.
