Crown lift by up to 1 metre. **RESOLVED: No Objection subject to the usual conditions of the tree officer to ensure that crown reduction is specific.** 

H/20/87200, Totford, 19 Grange Road, Hedge End. Single storey extension, Connecting extension from existing double garage to existing house.

**RESOLVED: No Objection** 

T/20/87343, 31 Stirling Crescent, Hedge End. 1 no. Macrocarpa (T1) - reduce laterals over garden of 29a Stirling Crescent by 3.5 metres. **RESOLVED: No Objection subject to the usual conditions of the tree officer.** 

T/20/87383, 156 Stirling Crescent, Hedge End. 1 no. Portuguese Laurel - Fell and replace with a Hawthorn. **RESOLVED: No Objection subject to the usual conditions of the tree officer.**
