Land to the East of Little Hatts Recreation Ground. RESOLVED: Cllrs raised concerns regarding the lack of services to the site. There were also concerns about the pipeline that runs in this area. Land usage is currently agricultural land and not mixed use and this appeal contravenes the agricultural aspect of the land. Objection.
