H/23/95605, 43 Allen Road, Hedge End. Single storey rear extension following demolition of existing conservatory, addition of porch to front, raising height of flat roof on garage by 300mm. **RESOLVED: No Objection.**

H/23/95578, 29 Goodlands Vale, Hedge End. Single storey side and rear wrap around extension. **RESOLVED: No Objection.**

T/23/95653, 12 Dean Court, Hedge End. 1 no. Lime - Crown reduce by approximately 5 metres to suitable growth points and reduce lateral spread to shape tree by approximately 2 metres. T/23/95775, 99 Watkin Road, Hedge End. 1 no. Willow (in the rear garden of the property)- Repollard to the existing points (pollarded approximately 5 years ago). **RESOLVED: No Objection subject to the usual conditions of the tree officer.**

T/23/95790, 1A Navigators Way, Hedge End. 1 no. oak - Tree requires a 2.5 metre crown reduction and 8 metre crown lift over the road for clearance of the lamppost and vehicles accessing the industrial estate. **RESOLVED: Object to 2.5m reduction** as it will finish the trees amenity value. No Objection to previous works of crown reduction of 1.5m subject to the usual conditions of the tree officer.

T/23/95837, 21 Rose Close, Hedge End. 2 no. oak trees - whole crown reduction to 12m above ground level, to provide sufficient clearance to the pool house, swimming pool and garden. RESOLVED: Object on the lack of evidence to support the application. The proposed works are excessive and will have a negative impact on the trees.

- Cllr John Jupe raised an email concern received from a resident regarding HGV's on Upper Northam Road. Councillors discussed that this has been raised several times with Hampshire County Council, however the response has always been that there are no accidents on that stretch and therefore no works will take place. Cllr Cynthia Garton will send a response.
