T/21/89954, Land to the rear of 5 Maidman Place, Hedge End. 1 no. oak (T1) - Clear epicormic growth from the main trunk and reduce lower laterals by 1 metre. **RESOLVED: No Objection subject to the usual conditions of the tree officer.**

T/21/89955, Land behind 26 Radley Close, Hedge End. 1 no. ash - Overall crown reduction by 2 metres and remove the two lowest limbs. **RESOLVED:**No Objection subject to the usual conditions of the tree officer.

T/21/89982, Unit 2, Royal London Park, Flanders Road, Hedge End. 4 no. Poplar (G11) - Fell leaning stem over bin store, 1 no. Oak (T12) - Remove low limb growing over entrance gate. Remove or cut back low branches to give a 5 metre clearance from ground level on the remainder of the tree on the estate side only 3 no. Cherry (G14) - Middle tree (Decay at base) - Fell as close to ground level as possible and grind out stump. Remaining two trees remove or cut back low branches to give a 3 metre clearance from ground level and prune back from the building. 1 no. Cherry (T15) - (fungal fruiting bodies at base) - Fell as close to ground level as possible. 1 no. Cherry (T16) - Remove or cut back low branches to give a 3.5 metre clearance from ground level and prune clear of the building elevation. 1 no. Lime (T17) - Remove or cut back low branches to give a 3.5 metre clearance from ground level and prune clear of the building elevation. 1 no. Lime (T18)- Remove or cut back low branches to give a 3.5 metre clearance from ground level and prune clear of the building elevation. Reduce the eastern stem over the highway. 1 no. Oak (T19) - Sever ivy. Prune back from the building elevation to provide 2 metres clearance. 1 no. Goat Willow (T20) - Cut back to boundary line. 1 no. Cherry (T21) - Remove or cut back low branches to give a 3.5 metre clearance from ground level. Prune clear of building elevation. 1 no. Oak (T22) - Remove or cut back low branches to give a 5-metre clearance from ground level on the estate side only. 1 no. Oak (T23) - Sever ivy. Prune back from building elevation to provide 2 metres clearance. **RESOLVED: No Objection** subject to a replant of G14 however replacement trees for any other felled trees including T15 & T16 should be planted either onsite or elsewhere in agreement with the Town Council and the usual conditions of the tree officer.

T/21/90020, 28 Marsh Gardens, Hedge End. 1 no. Oak (T1) - 2 metre crown reduction. **RESOLVED: No Objection subject to the usual conditions of the tree officer including a sensible limit on pruning wounds.**

T/21/90023, Land adjacent 4 Waylands Place, Hedge End. 1 no. Pine (T1) - Fell. **RESOLVED: No Objection subject to suitable replacement planting and the usual conditions of the tree officer.**

T/21/90022, 10 Maidman Place, Hedge End. 1 no. Oak (T2) - Reduce 1 heavy attenuated limb to the first major fork. 1 no. Oak (T3) - Reduce 1 low limb by 3 metres to maintain the tree to its surroundings. RESOLVED: Object to T2 based on the lack of supporting evidence and excessive pruning. No Objection to T3 subject to the usual conditions of the tree officer. Any works to be completed should be monitored by an EBC or HETC arboriculturist.

T/21/90112, Silver Birches, Dodwell Lane. 1 no. Oak (T1) - Crown raise to 5 metres. 1 no. Conifer (T2) - Reduce by 4 metres. 1 no. Holly (T3) - Reduce by 4 metres. RESOLVED: No Objection to T1 subject to the usual conditions of the tree officer. Object to T2 & T3 as excessive pruning, loss of visual amenity and the impact to the trees health with no supporting evidence provided.

- Cllr Carnell reported excessive takeaway litter in the village centre and could a facebook post be put out again.
- Cllr Carnell noted the queue for McDonalds was onto the highway which needs to addressed. Cllrs discussed this item which will be raised again at Full Council.
