H/22/92453, 18 Mapleton Road, Hedge End. First floor front extension.

RESOLVED: No Objection.

H/22/92511, 43 Elliot Rise, Hedge End. Proposed single storey rear and side extension. **RESOLVED: No Objection.**

H/22/92527, 17 Freegrounds Road, Hedge End. Single-storey rear extension.

T/22/92223, 30 Firs Drive, Hedge End. 1 no. Cherry (T1) - Retrenchment prune back to viable Union to reduce weight of heaved limb. **RESOLVED: Object as the application lacks sufficient information to make an informed decision.**

T/22/92249, 6 Stockton Close, Hedge End. G1= 1x Hawthorn, 2 x oak , 1 x ash. 1 no. Hawthorn (T1)- Reduce crown by 1.5m, prune side limbs prune back 0.5m. 1 no. Oak (larger tree T2) - Reduce crown by 1.5m, prune limbs by 0.5m. 1 no. Oak (T3)- Reduce crown by 1m, prune northern lateral limb by 0.5m. 1 no. Ash (T4) - Reduce crown by 3m. Tree has woodpecker holes and cavities. **RESOLVED: Object as the map and description are unclear and open to interpretation.**

T/22/92523, Eddisons Property Managers, Strategic Park, Hedge End. 6 no. Oak trees (T1, T2, T3, T4, T5 and T6)- Reducing branches by 1 to 2 meters back to the fence lines. **RESOLVED: No Objection subject to the usual conditions of the tree officer.**
