H/19/85907, 17 Sherborne Way, Hedge End. Two storey and single storey side extension. **RESOLVED: Strongly Object as not in keeping with the street scene, overdevelopment and is on land not owned by the application. Please refer to our previous objection to F/18/84599.**

F/19/85904, Sainsbury Supermarket, Tollbar Way, Hedge End. Erection of 1no. single storey retail pod attached to western elevation of supermarket. **RESOLVED: No Objection**

A/19/85958, Sainsbury Supermarket, Tollbar Way, Hedge End. Display of 3no. internally illuminated fascia signs, 2no. non illuminated side panel signs and 2no. non illuminated poster signs. **RESOLVED: No Objection**

F/19/86011, Sundays Hill Close, Bursledon Road, Hedge End. Introduction of gravel path inside site boundary to provide access to rear of terraced properties on plots 2 - 10. **RESOLVED: No Objection**

H/19/85920, 25 Rose Close, Hedge End. Single Storey Side Extension. **RESOLVED: No Objection**

H/19/85936, 9 Downscroft Gardens, Hedge End. Replacement single storey extension. **RESOLVED: No Objection**

H/19/85971, 20 Ratcliffe Road, Hedge End. Single story rear extension. **RESOLVED: No Objection**

T/19/85894, Crowmere, Upper Northam Drive, Hedge End. 1 no. Oak - To reduce lateral branches growing towards house by 2-3 metres. **RESOLVED: Object to the original wording on the application of 'reduce lateral branches growing towards house by 50%'**  
**No Objection to the amended wording on the website 'reduce lateral branches growing towards house by 2-3m' subject to the usual conditions of the tree officer.**

T/19/85926, 13 Rose Close, Hedge End. 1 no. Oak (T1) - Crown raise to 5 metres above ground. Thin crown by 10% and reduce the north-east side by 3 metres. **RESOLVED: Object to the original proposal. No objection to Part Consent/Part Refuse on an amended proposal – 'Crown raise to 4m from ground level and reduce the north-east lateral branches by up to 3m' subject to the usual conditions of the tree officer.**
