RESOLVED: Objection on the basis of contradictory information in the tree report. Protecting established trees should be a priority. Also note that the orientation labels are incorrect on the elevation plans.

H/21/90488, 53 Bursledon Road, Hedge End. Garage conversion to habitable accommodation. RESOLVED: No Objection.

H/21/90945, 19 Hackworth Gardens, Hedge End. Single storey rear extension and garage conversion. RESOLVED: No Objection.

H/21/90999, 20 Yardley Road, Hedge End. Single storey rear extension, part garage conversion and demolition and addition of cladding and render to front elevation. RESOLVED: No Objection.

T/21/90941, 72 Granada Road, Hedge End. 1 no. Oak (T1)- Crown reduction by 3 metres. RESOLVED: No Objection subject to the usual conditions of the tree officer.

Reduce overhanging branches by up to $3 m$ to alleviate weight and crown raise to a minimum of 5 m for vehicle clearance. Group of mixed species (G2) Target prune various trees to gain a minimum 2 m clearance from buildings and remove overhanging branches. 1 no. Oak (T2)- Target prune various lateral branches overhanging boundary by up to 3 m to gain 3 m clearance from the buildings. RESOLVED: No Objection subject to the usual conditions of the tree officer.

T/21/90958, The Bays, Greenfield Close, Hedge End. 1 no. Pine (T1) - Fell to ground level. 1 no. Pine (T2) - Reduce large branch in upper crown which has been resting and rubbing on T1. Limb to be pruned just inside damage caused by rubbing. 1 no. Pine (T4) - Remove tertiary limb growing over neighbouring summer house. RESOLVED: No Objection subject to the usual conditions of the tree officer. Consider the possibility of a replant or a tree donation for planting on a council site.

T/21/91014, 26 Alexandra Road, Hedge End. 1 no. Oak (T1) - Prune to clear garage by approx 3 m , crown raise by approx 3 m over pavement and 5.2 m over carriageway, crown reduce by approx 2 m and remove deadwood.
RESOLVED: No Objection subject to the usual conditions of the tree officer.

T/21/91041, 51 Stirling Crescent, Hedge End. 1 no. Macrocarpa - to reduce heavy overextending lateral limbs over the garden by 2 metres. RESOLVED: No Objection subject to the usual conditions of the tree officer.

T/21/91043, 10 Frensham Close, Hedge End. 1 no. oak (T1)- reduce low lateral limbs touching and above roof of property by 2.5 metres to suitable growth points clearing the property by approximately 3 metres. 1 no. oak (T2) - reduce low lateral limbs touching and above property by 2.5 metres. 1 no. beech (T3) - reduce low lateral limbs by 2 metres to clear property back to suitable growth points. RESOLVED: No Objection subject to the usual conditions of the tree officer.
