R298 Correspondence

i) Request from Hedge End Carnival Committee for the use of Greta Park and associated facilities for the Carnival 2nd & 3rd July and Firework Fiesta 12th November 2022

The Clerk put to the committee the following concerns following the Firework Fiesta held on the 13th November:

- 1. Toilet provision It was felt that there had not been enough toilet facilities made available for the numbers attending the event and that there should be the provision of portable toilets.
- 2. Waste left on the site. The Committee had litter picked the site, with the bags left for the Town Council to clear. Should this now be the responsibility of the Carnival Committee to remove or should the Council be responsible, along with the cost involved.
- 3. Provision of Risk Assessments and Public Liability Insurance
- 4. That the contact number given for the event had been that of the Town Council.

It was highlighted that this was a new committee, who were finding their feet, that credit should be given to them for stepping up and that support and guidance from the Town Council should be given.

Members had concerns on the cost to the Council for the removal of any waste. It was agreed that the Carnival Committee should now bear this cost for the council to remove.

RESOLVED: All agreed the request for use of Greta Park for the Carnival and Firework Fiesta next year and that a letter of support and guidance was sent to the Carnival Committee

 Request from Hedge End Carnival Committee for the placement of benches in Greta Park

With the monies available there was enough for the purchase of x2 benches that would replace the one that had been taken out along the pathway in Greta Park. Members were shown information on the various benches available.

RESOLVED: That x2 Lakeside benches were purchased and used to replace the removed bench located in Greta Park.

ii) Dowds Farm – Request for memorial bench A request from a local resident had been received for the opportunity to refurbish and place a memorial plaque to her late brother to an existing bench located at Dowds Farm. The bench concerned was special to the family and had been over the last 10 years. Members were given photos and information on the said bench for consideration.

RESOLVED: That the request to refurbish and place a memorial plaque on the requested bench was agreed, however it was asked that instead of a new pathway being put in, a gravel crescent shaped hardstanding was placed to the front of the bench.
