The clerk is instructed to respond with the Committee's appreciation, support and approval of this application, however, the location of planting to be deferred and decided during the meeting of September.

R12 Community Tennis Project

A Progress Report

Following a further meeting with James Deem of the LTA and Richard Cutler, Serving Tennis. The Council still awaits details of recommended specialists, in order to issue a specification and invitation to tender. Invitations to tender should be despatched before the end of July, with a submission date within the first week of September and commencement of works in October, 2014.

Early indications suggest that the project expense far exceeds the envisaged budgets that were initially discussed and an air of caution must be applied as there are no further monies available from the Town Council, especially as the council has already committed additional funds from the Solar PV income. The Budget must not exceed £24,000. In the meantime Richard Cutler, at the request of the Finance & Administration Committee, has produced a revised Business Plan, a copy of which is issued to each member this evening.

R14 To approve retrospective application for the use of HETC grounds - EBC Park Sports throughout the Summer 2014, together with a Skate & BMX Jam on 4th August, 2014.

An Email from Fintan Healy, Park Sport Co-ordinator, dated 7th July apologises for the delay in this information reaching the Town Council and assures the Committee that a note has been made to give at least two months' notice next year, and provides a schedule of activities taking place running between 28th July and 29th August. There will also be two one-off events: Skate Jam at Woodhouse Lane Leisure Park on Monday 4th August and Bikeability Level 1 at Greta Park on Tuesday 5th August.

At the Chair's invitation Cllr. Rupert Kyrle raised potential issues concerning the Bond Policy, in that whilst it was essential to protect public open space during commercial use and vehicular activity on the grounds, he asked whether members would consider an amendment with a view to giving more flexibility where charities are concerned and events that do not include a commercial influence or any kind of potential disruption of the grounds i.e. vehicles. Whilst an appropriate Management & Risk Assessment together with Public Liability Insurance is essential, the additional Bond of £1500 could discourage a simple charity event.

Resolved: To permit the use of Woodhouse Lane Leisure Park, Dowds Farm Park and Greta Park for the Park Sport scheduled events as submitted. The Committee will require two months' notice in the future. The Clerk is also instructed to raise new terms and conditions, retaining the £1500 Bond, but with more flexibility to encourage small charity events, and ensure that this is an Agenda item for the September meeting.
