4. To Receive a Police Report

PC Sandy Wyld attended the meeting together with PCSO Emma Berry. She explained the managerial changes in the police force especially relating to local arrangements. She stated that she will no longer be the Beat Officer for Hedge End as she is being transferred to Netley. PC Carl Osman will move from Netley to be the Beat Officer for Hedge End and PC Chris Lewis will cover Grange Park/Botley. PCSO Emma Berry was introduced to members and she will be one of the Hedge End PCSOs with effect from November 2014. PCSO Marc Vincent will be leaving his post from April 2015 and a separate PCSO will be recruited in due course. Therefore, the new beat team from November will be PC Osman, PCSO Berry and PCSO Vincent plus a new PCSO (to be confirmed later).

She reported that it has been relatively quiet in terms of incidents around Hedge End and there was little to report.

PC Wyld therefore advised members this would be her last attendance at this meeting and members conveyed their appreciation with a round of applause.

Cllr. Nathan Khan commented it would be a very nice touch if relatives of those soldiers commemorated on the War Memorial could be towards the front of the parade on Remembrance Sunday.
