A number of TROs (Traffic Regulation Orders) have been agreed for Barton Drive and Cheltenham Gardens and a traffic study has been commissioned for Maunsell Way/Berrywood School. He also reported that he is involved with the Southampton Airport consultation on extending the runway.

Cllr. Cynthia Garton reported that there is a working party formed to consider replacement of the poor Berry Theatre gates and to look at the proposed art work to consider replacement thereof. She reported that there are now yellow lines along Pretoria Road.

Cllr. Keith House advised that the Ratcliffe Road issue is on the forthcoming agenda for the HEWEB LAC to discuss. He advised that the new road link at Heath House Lane to Dodwell Lane is nearly finished and the road link will be named Barnfield Way.

County Cllr. Rupert Kyle advised that he will be attending the full Hampshire County Council meeting on 20 September 2018 where the medium-term financial strategy vision for the future will be decided. The proposal for agreement will take £380 million out of the operating budget, which equates to 13-14% cut in the budget.
