4. To Receive a Police Report

PCSO Tracey Chilcott provided the statistics in advance and presented some highlights from the report. There were concerns about the vehicle speeding, noise nuisance and car meet ups, this has resulted in at least 2 operations each month with some further ones planned for March. There have been some discussions about having ANPR cameras. The police are looking at identifying the worse sites and then working with the landowners on prevention. There will be a community survey thorough Hampshire Alerts in March although not many people have signed up to this service.

PCSO Chilcott spoke about the speed awareness signs that are on some roads in Hedge End and could some more of these be installed in some of the other areas.

Cllr Craig reported that driving has become particularly bad since the closure of Charles Watts Way and drivers are blocking entrances and exits and using incorrect lanes coming off the Windhover Roundabout.

Cllr Paul Carnell asked if checks were made on modified vehicles and the insurance is correct. PCSO Chilcott confirmed that this is checked.

Cllr Cliff Morris joined the meeting.
